LANE J. BEOUGHER was born in Columbus, Ohio, in 1961. A member of First Families of Ohio, he is a seventh generation native who is proud to serve the citizens of his home state and local community.

Lane was trained as a draftsman at Muskingum Area Joint Vocational School in Zanesville, Ohio. While working at NCR Corporation’s plant in Cambridge, he joined CSI and began absorbing all the technical information he could. However, it wasn’t until he began working evenings for an architect that he discovered his true calling, and enrolled in the Austin E. Knowlton School of Architecture.

After graduating, Lane specialized in restaurant design, using his industrial operations research and management knowledge to create efficient kitchen and dining prototypes. Later, as an Associate and Senior Project Architect for Braun & Steidl Architects, he was involved in design and construction of numerous educational and institutional projects, including the \$25 million Veterinary Medicine Academic Building at his alma mater.

As the Program Services Manager at the State Architect’s Office in the Ohio Department of Administrative Services, Lane led the energy services and communications teams; wrote model agreements for architects, engineers, and other consultants; and wrote standard terms and conditions for construction contracts. During a major revision beginning in 2005, Lane realigned the state’s contracts and documents with MasterFormat 2004 and CSI guiding technical principles.

Lane was influential in Ohio’s early adoption and mandate to use MasterFormat 2004, inclusion of the CSI Construction Education Network in continuing education rules filed by the Ohio Architect’s Board, and listing of CSI certifications in the state’s request for qualifications.

As an expert on the state’s public construction processes, Lane was a major contributor to development of Ohio’s enterprise-wide Web-based program and project management system. He was also a key participant in efforts to reform Ohio’s public construction law to improve efficiency through alternative project delivery methods.

Lane has served CSI as a leader at every level, gaining national prominence as a co-author and presenter for the MasterFormat Accredited Instructor program; he was one of CSI’s most prolific national speakers during the transition to MasterFormat 2004.

An active member of other industry organizations, Lane served as president of the Columbus Chapter, AIA, in 2008, and received the AIA Ohio’s Public Service Award. He also was founding vice chair and regional representative for the Central Ohio Chapter of the U.S. Green Building Council.

Lane lives with his wife, Stephanie, an organizational communications professional, and son Nathaniel, who as a high school student has expressed an interest in architecture. They reside in Reynoldsburg, a suburb of Columbus, where Lane has served on its planning commission, city council, fire department board of trustees, and design review board
