Ken enjoys discussing and sharing issues related to construction specifications. He has presented at numerous CSI Chapter meetings, North Central Region Conferences, CSI Annual Conventions, and organizations outside CSI. His presentations have addressed issues relating to the preparation of specifications, including such topics as Drawing Notations, Keynoting, Architectural Specification Writing, Architectural Detailing, Or-equal in Specifications, Door Hardware, Specifications for Engineers, State Building Code: Road to a State Code, and Specifications for Historic Preservation.

Ken has also worked to improve building codes in the State of Illinois by serving on the AIA Illinois Council responsible for reviewing legislation that addressed building codes. This work led to the creation of the Illinois Building Commission,

to which he was appointed as the Architect representative and served as its first secretary. He later chaired the Commission.

Ken has participated in Chicago Chapter Education Programs as a presenter from 1994 to 2004 CSI Chicago Chapter education and certification courses.

Ken contributed to the master specifications series for ARCOM Master Systems, Inc.: “Special Procedures for Historic Treatment”; Historic Treatment of Ornamental Metal”, “Historic Treatment of Wood Windows”; and” Historic Painting”.

Ken’s interests are expressed in a few collections he maintains, including midwestern prairie grasses, a vinyl LP record collection, and an old book collection including one of the most complete collections of the Construction Specifier.
