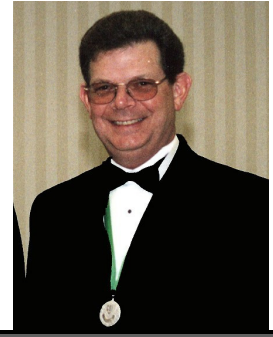


# Michael A. Glass, FCSI
