JONATHAN M. MILLER started life in 1955 as an Indiana Hoosier, the third of six children by Paul and Elaine Miller.

Mr. Miller earned a B.S. Design from Clemson (SC) University, and an M. Arch from the University of Minnesota. From 1976, off and on, until 1981, he was a staff member of the Planning & Engineering Department and a Special Assistant to the Director of the Harrisburg (PA) Redevelopment Authority. His varied career includes paperboy, dishwasher, roofer, Art & Architectural History Teaching Assistant at the University of Minnesota, and visiting lecturer teaching an architectural detailing lab at Vermont Technical College. With 23 years of architectural experience since 1983 as an AIT, Associate Designer, Project Designer, Staff Architect, Project Architect, Project Manager and Specifier with large (550+), medium (20 to 66), and small (>5 person) firms, including his own, Jonathan has focused his professional efforts on providing specification consulting services since 2002. Projects have ranged from state park facility renovations and a house, to embassy office fit-outs, theaters, college buildings, 80 story mixed-use

highrises, cultural museums, hospital complexes, and megamalls.

Miller's first CSI experience included sitting next to past president, John C. Anderson, FCSI, CDT, who, along with Doug Lingren, Peter Norum, and Alana Griffith, imprinted networking and education as CSI's main benefit. Since 1982 Mr. Miller has volunteered and served on the boards of the Linden Hills Food COOP in Minneapolis, Minneapolis-St. Paul Chapter CSI, Vermont Chapter CSI, Vermont Green Building Network (VGBN), a Chapter of USGBC, and the Northeast Region CSI.

Green and sustainable issues have been a personal and professional interest to Miller since his family was forced to temporarily relocate from the Three Mile Island incident on March 28, 1979. Many of his awards were for efforts involving environmental issues.

Jonathan is a Registered Architect in Vermont and is currently a Specification Consultant in Independent Practice in Middlebury, Vermont, where he provides specification and sustainability consultant services.
