MARILYN SMITH'S early years were spent in South Dakota, where she was born, and North Dakota until her family moved to Long Beach, CA in 1941. A fourth generation North Dakotan, she was brought up to expect to work hard and reach high to achieve as much as she could. At a time when women were not always encouraged to become architects, she decided it was the dream she wanted to pursue.

She is a graduate of UC Berkeley's College of Environmental Design where she was strongly influenced in the Bay Area holistic approach to design by educators such as William Wurster, Ted Bernardi, Gerald McCue and Joe Esherick, the legacies of Bernard Maybeck and Julia Morgan, and guest-lecturers Bruce Goff, Charles Eames and Buckminster Fuller.

Marilyn has been a specifier, project architect/manager, and mentor to her co-workers in offices in Southern and Northern California, and Northern Virginia for projects throughout the United States, most notably for offices such as Ward Hall Associates in Fairfax, VA and AECOM (DMJM) and Perkins+Will in Los Angeles, CA on projects such as the Ronald Reagan Hospital at UCLA's Medical Center.

She established her own practice as SpecSmith Consulting in 2005, focusing on specifications, quality control reviewing, project coordination, staff training, and mentoring of others.

Realizing in 2005 the tremendous need to educate more people in the proper preparation and use of construction documents, she took on the daunting task of rebuilding the certification programs of the Los Angeles Chapter of CSI. The outstanding success of these programs has inspired others to become involved with the programs, take leadership positions in the chapter, and carry on the work of the Education and Certification Committees as they grow and expand their programs locally and online, and reach out to new markets such as government agencies.

In recognition of her efforts and her inspiration to others, Marilyn has received several Awards from the Institute, West Region, and Los Angeles Chapter of CSI. Since returning to her home state of North Dakota in 2008, she has provided valuable input to new CDT, CCS, and CCCA materials, and continues to promote CSI's certification programs on the Institute, North Central / West Region, and Chapter levels..
