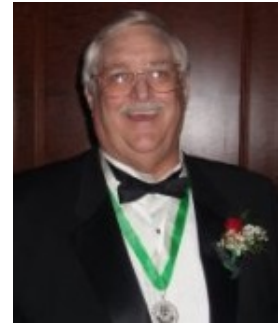


# Harold S. Woolard\*, FCSI

HAROLD S. WOOLARD was born in Sherman, Texas, May 10, 1949. He graduated from Justin F. Kimball High School in Dallas, where he was a four-sport letterman. He later attended college at El Centro College in Dallas, where he graduated with an Associates Degree. He was a member of the 94th General Hospital for the Army Reserves from 1970-1976, and was Staff Sergeant in charge of the dietary section of the hospital.

He started his construction career as an Inspector for the Texas Highway Department for four years, and later worked as head of Quality Control of Concrete Pavement for Texas Bitulithic (APAC) in Dallas, for ten years. He joined W.R. Meadows of Texas in 1978 as a Technical Salesman with responsibility for Texas and Oklahoma. He was promoted to Sales Manager in 1983, and received his first Salesman of the Year award from W.R. Meadows that year.

Harold joined CSI in March 1978 as member of the Dallas and Fort Worth Chapters. He was elected Treasurer of the Fort Worth Chapter in 1987.

Harold was promoted to General Manager of the W.R. Meadows Benicia, California, location in 1987, and helped with development of several products in the waterproofing

department while in California. He returned to Texas in 1991, and took over the Sales Territory of Houston and the state of Louisiana.

In 1991, he joined the Houston Chapter, became Chapter Treasurer in 1996, and Chapter President in 2002. He was then asked to become Institute Director for the South Central Region in 2003, to fill out a term left vacant by the Industry Director. He is currently Chapter Treasurer for Houston and South Central Region Treasurer.

Harold and his wife Jane reside in Montgomery, Texas; they have two children and two grandchildren. He loves golf, fishing, and antiques. He has been president of Athletic Booster Clubs in California and Texas, served on the board of directors for Lions Club International, and served as building committee chairperson for his church. He currently is head Construction Specification Coordinator for W.R. Meadows of Texas.

Harold passed away 12 December 2016 at his home in Montgomery, Texas.
